In response to your request dated July 9, 2010 under the Freedom of Information Act (Title 5 USC Section 552), we conducted a search of our Central Foreign Policy Records and retrieved seven documents responsive to your request.

After reviewing these documents, we have determined that seven may be released with excisions. All released material is enclosed.

An enclosure provides information on Freedom of Information Act exemptions and other grounds for withholding material. Where we have made excisions, the applicable exemptions are marked on each document.


With respect to material withheld by the Department of State, you have the right to appeal our determination within 60 days. A copy of the appeals procedures is enclosed.

The Freedom of Information Act provides for the recovery of the direct cost of duplicating records requested for non-commercial use by a representative of the news media. However, no fee is charged for the first one hundred pages of duplication. Since fewer than one hundred pages have been duplicated in this case, your request has been processed without charge to you.

We have now completed the processing of your case.
